Our organisation

VicTrack owns Victoria's rail transport land, assets, and infrastructure. We work to protect and grow the value of the portfolio, to support a thriving transport system and make travel and living better for all Victorians. With much of our asset portfolio dedicated to rail transport – our land, infrastructure, trams, trains and telecommunication networks – our focus is on strategic asset management and supporting the delivery of better transport solutions.

Whether we're planning and managing the use of transport land, upgrading the telecommunication network or partnering on major infrastructure projects, our job is to ensure the state's assets continue to serve Victoria now and well into the future.

Our core functions include:

- delivering telecommunications infrastructure and services that form the backbone of the transport network from signalling, driver communications, public information displays and myki ticketing
- managing land set aside for transport purposes, including the development and sale of land no longer required for transport to optimise its use
- generating income through land sales and commercial leases that is reinvested into the state's transport system
- providing project management, engineering and construction services to deliver a range of government transport projects from Victoria's Big Build to station and car park upgrades
- managing transport facilities and assets, including the open access Dynon Rail Freight Terminal, heritage buildings and environmental preservation.

VicTrack's Telecommunications Network is deemed 'vital critical infrastructure' – being of state significance and therefore critical to the continuity of the supply of essential services to the state, and to the overall economic and social wellbeing of Victorians.

VicTrack is the custodial owner of most of Victoria's tourist and heritage assets and performs the role of Tourist and Heritage Registrar.

Purpose of the position

The Enterprise Risk Management Specialist supports VicTrack's risk management functions. This includes frontline operations, senior management, executive committees, and the Board.



This role provides support and specialist advice on a broad range of enterprise risk management practices, including business continuity, enterprise security, crisis management, organisational resilience, and operational risk.

This role assists in maintaining and sustaining VicTrack's enterprise capability and resilience, in addition to contributing to VicTrack's continuous improvement practices, to protect and enhance Victoria's rail land, buildings and infrastructure.

This role supports the Victorian Government's Emergency, Resilience and Risk Management objectives.

The role also contributes to the Commonwealth Government's Critical Infrastructure Security and Risk management objectives.

Key accountabilities/functions

- Consolidation and curation of key risk awareness and intelligence content for VicTrack's risk and compliance stakeholders.
- Preparation and delivery of risk assessments, reviews, and reporting across VicTrack.
- Support select enterprise risk committees, forums and working groups.
- Support knowledge transfer, risk awareness and enterprise resilience training initiatives.
- Support the Group Risk insurance management and administration requirements.
- Liaise with Group Compliance and Group Asset Management functions to ensure alignment and integration of VicTrack's enterprise risk management strategy and objectives.
- Support the Internal Audit Program of Work, project delivery and reporting.
- Maintain situational awareness and threat monitoring, specific to Government Services, Critical Infrastructure and Public Sector Utilities.
- Represent VicTrack in select community forums and key stakeholder engagements.
- Maintain and support VicTrack's enterprise risk management platform.
- Maintain a high level of professional knowledge, industry awareness and subject matter expertise.

Customer focus

VicTrack staff practise customer focus by recognising the importance of valuing customers (internal and external) and ensuring that all activities are oriented towards meeting customer needs. We listen to customers about their expectations and focus on delivering solutions that address their needs. - take whatever action is possible to prevent unsafe conditions and/or incidents
- report any railway safety problems/hazards to the Manager Safety
- safely access the rail corridor.
