### Our organisation

VicTrack is custodial owner of Victoria's rail transport land, assets and infrastructure. We work to protect and grow the value of the portfolio, to support a thriving transport system and make travel and living better for all Victorians. With much of our asset portfolio dedicated to rail transport – our land, infrastructure, trams, trains and telecommunication networks – our focus is on strategic asset management and supporting the delivery of better transport solutions.

Whether we're planning and managing the use of transport land, upgrading the telecommunication network or partnering on major infrastructure projects, our job is to ensure the state's assets continue to serve Victoria now and well into the future.

#### Our core functions include:

- delivering telecommunications infrastructure and services that form the backbone of the transport network from signalling, driver communications, public information displays and myki ticketing
- managing land set aside for transport purposes, including the development and sale of land no longer required for transport to optimise its use
- generating income through land sales and commercial leases that is reinvested into the state's transport system
- providing project management, engineering and construction services to deliver a range of government transport projects from Victoria's Big Build to station and car park upgrades
- managing transport facilities and assets, including the open access Dynon Rail Freight Terminal, heritage buildings and environmental preservation.

VicTrack is the custodial owner of most of Victoria's tourist and heritage assets and performs the role of Tourist and Heritage Registrar.

# Purpose of the position

The Asset Inspector will be responsible for undertaking inspections of Property Group's infrastructure assets, which includes an extensive portfolio of buildings and facilities. In conjunction with the Maintenance team, the Asset Inspector will play a vital role in the engagement and supervision of contractors for various maintenance and rehabilitation works, which also extend to the portfolio of over 100 bridges of which the Property Group is the custodian.



The Asset Inspector will work closely with the Infrastructure team to plan inspections, identify and oversee the resolution of all defects and problems, and contribute to the continuous improvement of programs and associated processes.

The Asset Inspector will have a genuine interest and passion for the management of infrastructure assets. They will be competent using contemporary tools to perform their role, including use of tablet devices and associated apps. They will be proactive in contributing to the preservation and maintenance of our assets, assisting in the identification and resolution of problems before they escalate. They will demonstrate accountability for the work they undertake and get engaged to do.

# Key accountabilities/functions

- Manages condition and compliance assessments on a variety of buildings and other assets in accordance with the infrastructure asset inspection program and procedural requirements, and ad hoc inspections where required.
- Prepare accurate, complete and actionable reports for all inspections undertaken to assist with preventative maintenance and capital program.
- Responsible for the preparation of maintenance plans and schedules, including facilitating budget preparation to support bridge Capex and Opex programs.
- Undertakes audits of completed maintenance and rehabilitation works, and ensure contractors comply with agreed scopes of work.
- Undertakes audits and liaises with contractors for Essential Safety Measures to assist with issuing Annual Essential Safety Measures Reports (AESMR) or Non-Conformance Statements.
- Supports reviews of processes, procedures and related activities such as failure modes and effects analyses.
- Manage and produce reports on inspections, presenting findings to relevant internal stakeholders, ensuring a high standard of data quality during inspections and all data collection activities.
- Manage and produce reports in inspections, presenting findings to relevant internal stakeholders and identify and resolve issues relating to preservation and maintenance of assets, escalating as required.
- Manage rectification of bridge defects in conjunction with contractors to ensure a
  responsive and timely approach to necessary works, appropriate to the level of
  defect severity. Assess if works are completed to a high standard, implement
  corrective actions if defects or quality issues are identified.
- Provide technical support and assistance to the Asset Systems Officer with regard to asset management and asset maintenance.

### **Customer focus**

VicTrack staff practise customer focus by recognising the importance of valuing customers (internal and external) and ensuring that all activities are oriented towards meeting customer needs. We listen to customers about their expectations and focus on delivering solutions that address their needs. Customer focus also includes proactively seeking and acting on feedback to enhance the customer experience.



## Safety and environmental responsibilities

- be aware of the railway safety requirements associated with their duties and responsibilities
- take whatever action is possible to prevent unsafe conditions and/or incidents
- report any railway safety problems/hazards to the Manager Safety
- · safely access the rail corridor.
