# Our organisation

VicTrack is custodial owner of Victoria's rail transport land, assets and infrastructure. We work to protect and grow the value of the portfolio, to support a thriving transport system and make travel and living better for all Victorians. With much of our asset portfolio dedicated to rail transport – our land, infrastructure, trams, trains and telecommunication networks – our focus is on strategic asset management and supporting the delivery of better transport solutions.

Whether we're planning and managing the use of transport land, upgrading the telecommunication network or partnering on major infrastructure projects, our job is to ensure the state's assets continue to serve Victoria now and well into the future.

#### Our core functions include:

- delivering telecommunications infrastructure and services that form the backbone of the transport network from signalling, driver communications, public information displays and myki ticketing
- managing land set aside for transport purposes, including the development and sale of land no longer required for transport to optimise its use
- generating income through land sales and commercial leases that is reinvested into the state's transport system
- providing project management, engineering and construction services to deliver a range of government transport projects from Victoria's Big Build to station and car park upgrades
- managing transport facilities and assets, including the open access Dynon Rail Freight Terminal, heritage buildings and environmental preservation.

VicTrack is the custodial owner of most of Victoria's tourist and heritage assets and performs the role of Tourist and Heritage Registrar.

# Purpose of the position

The Senior Environment Project Specialist is responsible for the delivery of VicTrack's environmental projects to support the organisation's operational environmental risk management programs.



The Senior Environment Project Specialist provides advice and support across the areas of land contamination, flora and fauna, and cultural heritage, as well as corporate sustainability and general environmental management as appropriate.

# Key accountabilities/functions

- Project manage environmental projects including in contaminated land, remediation and biodiversity, through scoping, procurement, contractor management and budget management, to support the delivery of VicTrack's environmental programs.
- Maintain and update environmental data in VicTrack's Contaminated Land Hazard Assessment and Mapping Program (CHAMP) system, RailMap, and related registers through precise collation, review and input, enabling effective risk ranking, informed decision-making for future programs, actions tracking, analysis of trends and accurate location mapping of environmental attributes.
- Provide expert environmental advice on projects and land uses, by reviewing reports and records to manage environmental risk, ensure VicTrack's interests are maintained and embed environment in business operations.
- Analyse current workflows to identify process improvements and develop tools, checklists, and forms that enhance efficiency and support environmental compliance.
- Conduct site inspections across Victoria to identify and mitigate environmental issues, manage contractors, and support implementation and compliance with management plans.
- Identify environmental risks and controls to mitigate non-compliance with environmental laws, including the development and review of policies and procedures and management plans to support VicTrack's Environmental Management System.
- Represent VicTrack in external committees, forums, and consultative groups to foster relationships and advocate for the organisation's environmental interests.

#### **Customer focus**

VicTrack staff practise customer focus by recognising the importance of valuing customers (internal and external) and ensuring that all activities are oriented towards meeting customer needs. We listen to customers about their expectations and focus on delivering solutions that address their needs.
